#### Groups 1 - 3 final recommendations

## Group 4 – local inquiries – the South London boroughs

2. The Assistant Commissioners who conducted the local inquiries have submitted their reports to the Commission. A news release announcing the Commission's conclusions on the Assistant Commissioners' recommendations will be issued on 12 December 2001. The local inquiries conducted were:-

Bexley and Greenwich – held on 10 July 2001;
Bromley and Lewisham – held on 26 July 2001;
Lambeth and Southwark – held on 4 and 5 July 2001; and
Wandsworth – held on 3 July 2001.
```

3. Final recommendations for Croydon, Kingston upon Thames and Richmond upon Thames, Merton, and Sutton, where local inquiries were not required, were announced on 25 April 2001. Any further representations received in respect of these boroughs will not be considered.

#### <u>Group 5 – local inquiries – the North London boroughs</u>

4. A series of local inquiries for the boroughs set out below is nearing completion:-

**Barking and Dagenham, and Havering** – held on 14 November 2001;

Brent, Camden, City of London, Hammersmith and Fulham, Harrow, Hillingdon, Hounslow, Kensington and Chelsea, and Westminster – one inquiry held between 29 October and 9 November 2001;

**Ealing** – held on 12 November 2001;

**Enfield** – held on 7 November 2001:

**Hackney, Islington, Newham, and Tower Hamlets** – one inquiry held between 26 and 28 November 2001:

Haringey – to be held on 29 November 2001; and

**Redbridge and Waltham Forest** – held on 8 November 2001.

- 5. The reports on the local inquiries will be submitted to the Commission in due course by the Assistant Commissioners who conducted them. A news release announcing the Commission's conclusions on the Assistant Commissioners' recommendations will be issued in April or May 2002.
- 6. Final recommendations for Barnet, where a local inquiry was not required, were announced on 12 September 2001. Any further representations received in respect of this borough will not be considered.

# Group 6 – local inquiries – Warwickshire, Swindon, and Wiltshire

7. On 7 November 2001, the Commission announced that they would be holding the following local inquiries:-

**Warwickshire** – the inquiry will open at 10.30 am on Tuesday 29 January 2002 in the Shire Hall, Warwick.

**Wiltshire** – the inquiry will open at 10.30 am on Tuesday 22 January 2002 in the Banqueting Hall, The Guildhall, Market Place, Salisbury.

8. The Commission noted that they were not required to hold a local inquiry for Swindon and decided not to use their discretion to hold one. Therefore, final recommendations for the county were announced on 7 November 2001. Any further representations received in respect of Swindon will not be considered.

# <u>Indicative timetable for future groups of review areas</u>

9. Subject to the completion of the necessary Periodic Electoral Reviews, including ward boundaries, and the provision of the appropriate electoral information by the Electoral Registration Officers, it is anticipated that the next counties will be:-

Hampshire, Portsmouth, and Southampton Nottinghamshire and Nottingham Staffordshire and Stoke-on-Trent

10. It is expected that provisional recommendations for these counties will be published in February 2002.

#### Machinery of Government changes

11. Shortly after the general election, the Government announced that responsibility for electoral law would transfer from the Home Office to the Department for Transport, Local Government and the Regions (DTLR). The Commission's sponsoring body is therefore now DTLR rather than the Home Office. This in no way affects the Commission's independence or the timetable for the fifth general review.

#### Difficulties with deliveries to the Commission's PO Box

- 12. During late June 2001, the Commission were informed that difficulty was being experienced in the delivery of petitions, sent by Special Delivery, to their PO Box and was being returned marked as "PO Box closed". Letters posted during this period by  $1^{st}$  or  $2^{rd}$  class post appeared to have been delivered without any difficulty.
- 13. The Commission have investigated why this difficulty was encountered and it has been confirmed that the PO Box was erroneously closed for a short period of time. This was due to the number of the Commission's PO Box being very similar to that of another for which the annual fee had not been paid. The Commission apologise for any inconvenience the error may have caused.
